Sirs

I have written to the justice Department concerning an investigation that the FBI conducted against Carlos Marcello. As yet the have not replied to my letter. I also wish to bring your office up to date as to what i have done since i learned that Carlos Marcello has found out that i was involved in the investigation with the FBI.

I called Agent Ray Holt in Tyler Texas as he was handleing the investigation. Also the Agent that i am working with now Agent Carl Pasadre called Ray Holt. I was told that Agent Holt said that he did not think that Marcello could have found out what we did to him as all documents are sealed. I am sure that he does not ~~think~~ know all we did to him only that a wire tap was done against him, and that i was involved with the FBI against him. It is what he does not know that makes him dangerous.

I know that man he does not forget any thing. Ray holt said that he could not contact my family as he can do nothing until a threat was made. This is not much consolation for me. I do not worry for myself but i do worry that he might try to get back at me through others. Carlos Marcello has enough conections at Texarcana he can find out any thing that he wants. Once he came to me with a copy of my complete record PSI report. His Coment to me was that he wanted to know all about the people that were his friends.

The Justice Department has all of the evedence that we gathered in the investigation. They hold the bribe money that was paid to an Undercover FBI Agent he is of course Tom Kirk. They have all the tapes with hundreds of hours of conversations. Ray Holt and Agent Kimmel were told how in a fit of rage he Carlos Marcello told me and inmate Don Wardell that he had John Kennedy murdered. I believe that your office should make Senator Kennedy aware of this evedence. If you feel that i should do that i can Contact Senator Cranston and ask him to pass the information on to him.

People no matter who that comit a crime against another should be tried and if convicted sent to Prison In the Case of Carlos marcello, he shoul have to stay in Prison all his life. His son should be brought to trial and if convicted sent to Prison with his Father. That would cut off the Blood line to the Mafia in the South East. There are many mor things that i could tell you about the little Man things that could not be discused in the citation that we found our selves during the investigation. I would go on the stand against this Man and his Son any time that i was asked to do so. I hope that you will write me back to answer some of these questions and worries that i have talked about here. As you know i still work closley with the San Francisco FBI and help them all i can.
