DEAR SIR.

FROM MARCH 1985 TO APR. 1986 I WAS ASKED BY THE FBI TO HELP WITH THE INVESTIGATION OF CARLOS MARCELLO AT TEXARKANA FEDERAL PRISON. I FEEL THAT I CARRIED OUT MY PART OF THE AGREEMENT AS SET DOWN BY THE PEOPLE THAT I WAS WORKING FOR. WITHOUT GOING INTO A LOT OF DETAIL IN THIS LETTER, PLEASE LET ME KNOW IF YOU INTEND TO CHARGE CARLOS MARCELLO AND JOE MARCELLO FOR BRIBERY IN AS MUCH AS JOE MARCELLO PAID AN UNDERCOVER FBI AGENT FOR HAVING CARLOS MARCELLO MOVED FROM TEXARKANA TO SEGOVILLE AND FROM SEGOVILLE TO FORT WORTH PRISONS. I ALSO WISH TO KNOW WHAT HAPPENED TO THE INVESTIGATION, THE INFORMATION THAT I REPORTED TO RAY HOLT AND MR KINMELL OF THE TYLER OFFICE OF THE FBI. IN AS MUCH THAT CARLOS MARCELLO TOLD ME AND ANOTHER INDIVIDUAL BY THE NAME OF DON WARDELL THAT HE CARLOS MARCELLO DID IN FACT CONSPIRE TO HAVE JOHN KENNEDY MURDERED. I FEEL THAT I HAVE A RIGHT TO THE ANSWERS TO THESE QUESTIONS. IS THE INVESTIGATION CLOSED OR ARE YOU STILL CARRYING ON YOUR INVESTIGATION. I TALKED TO RAY HOLT AFTER XMAS. AND HE TOLD ME THAT TOM HERR THE UNDERCOVER AGENT WAS ONLY ABLE TO OBTAIN TWO PAYMENTS FROM JOE MARCELLO, WELL AS FAR AS I AM CONCERNED THAT WAS A CRIME. I PUT MY HEAD ON THE LINE IN THAT INVESTIGATION SO SOMETHING SHOULD BE DONE. HOPING TO HEAR FROM YOU.

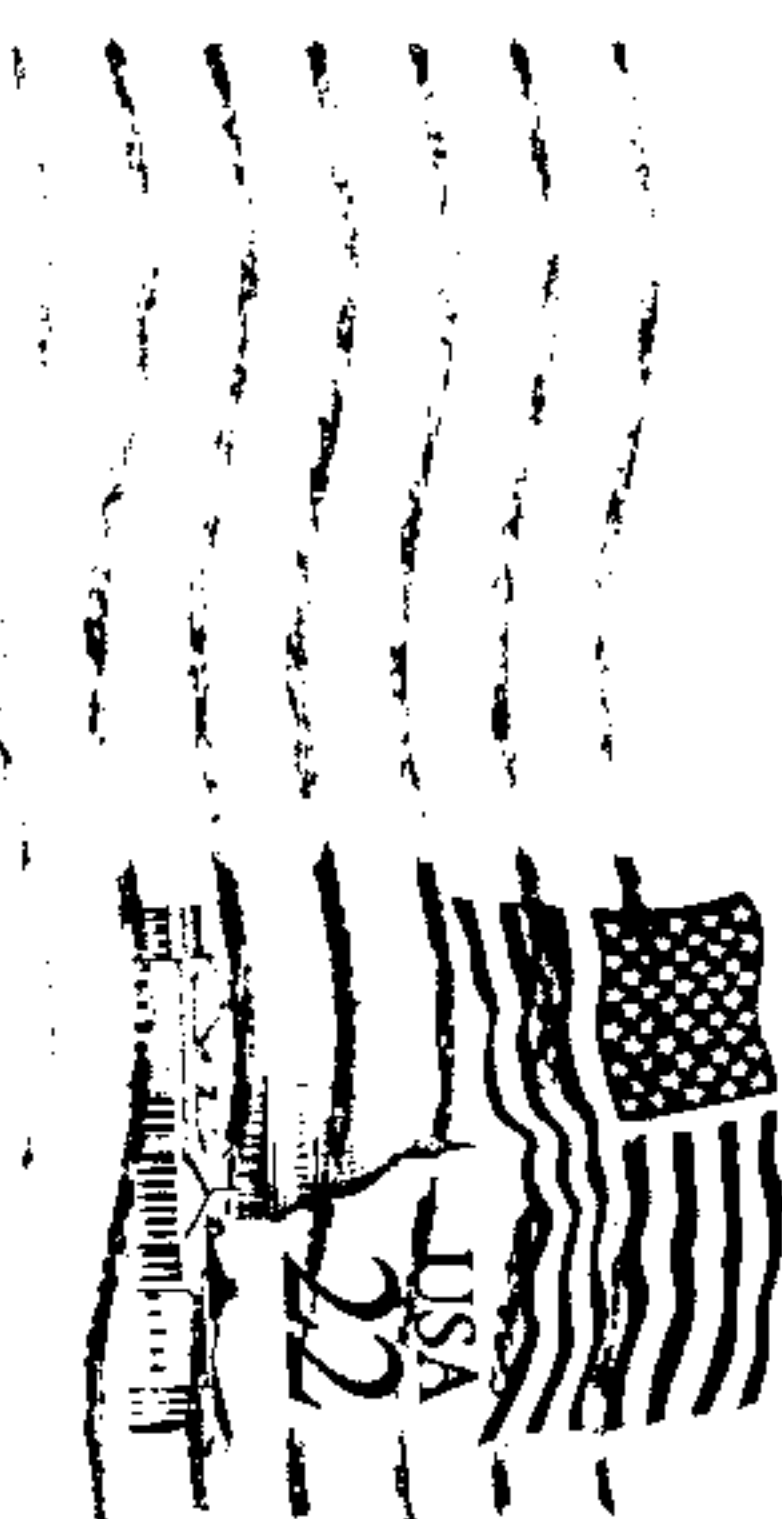
